# **EMT Basic**

This course is the introduction into Emergency Medical Services. During your training you will learn to handle emergencies such as heart attacks, childbirth and how to perform skills such as splinting broken bones and maintaining a trauma patients airway.

The EMT class is fast paced and you must prepare ahead of time by reading and studying. Upon completion, you should be prepared to take the North Carolina EMT basic exam. Before receiving the EMT certification from the state, NCOEMS will do a complete background check on the student.

Classes are held Monday, Wednesday, and Friday from 9 a.m. to 1 p.m. OR Tuesday and Thursday from 6 to 10 p.m. at the Continuing Education Center, 701 W. Front Street, Statesville.

#### Fees

#### **Fee Waiver**

If affiliated with a municipal/volunteer fire or rescue department, your registration fee can be waived.

#### Requirements

- If you are under 18 years of age, but at least 16, you can attend but there are special forms to be used.
- You must have high school diploma, GED, or proof of a 10th-grade reading level.
- A Hepatitis B Vaccination and TB Test are required before starting.

Mitchell Community College offers:

#### ■ EMT - Intermediate

Prepares you to take the North Carolina EMT intermediate exam. Prerequisite: successful completion of EMT Basic.

#### ■ EMT - Basic to Paramedic

This is a 13-14 month program. You must have an EMT-B card and had anatomy. (Placement test required.)

## EMT - Continuing Ed
